NOTICE FOR RENEWAL OF ADMISSION

(Term - 1st April 2022 to 30th September 2022)

Students are advised to note that the existing term will expire on 31st March 2022. Eligible students applying for **Renewal of term** are advised to refer the following carefully:

1. Click on link - “**Admission Process**” on our website www.rvgef.org and refer to the ‘**Procedure for Renewal of Admission**’ & ‘**Rules & Regulations**’
2. Online Renewal Application form shall be available on the Website from **Tuesday, 1st February 2022 (11:00 am) to Saturday, 12th February 2022 (5.00 pm)**. Student(s) failing to apply within the above mentioned time line shall not be eligible for renewal of admission.

3. After applying Online, take print out of form and submit all required documents and fees at the Office from **10:00 am to 6:30 pm between 2nd February 2022 to 13th February 2022**.

In case you are not able to personally submit the forms and documents, kindly ensure its receipt at our office i.e. RVG Educational Foundation, 57, Lallubhai Shamaldas Marg, Andheri (W), Mumbai 400058 on or before Sunday, 20th February 2022 by courier / post.

(**Please note:** Application forms will be accepted only during office hours on all days as mentioned above, except on Wednesday / Public Holidays.)

Considering the COVID-19 Situation, you may also upload the scanned copies of all the documents as per the timelines mentioned in the notice. Payment can also be done online.

4. Under the system of evaluation, students not performing within the parameters and not following the Rules & Regulations of this institution shall not be granted renewal of their admission.
5. Incomplete forms will be rejected. Any documents yet to be submitted during your admission process needs to be submitted, failing which your renewal shall be kept on hold or rejected.
6. If a student does not renew the admission, he/she has to vacate the hostel on or before completion of the current term i.e. 31st March 2022 or on the last day of his/her Articleship (If ending before 31st March 2022) whichever is earlier

7. Student(s) who will complete their Articleship on or before 30th June 2022 will not eligible for Renewal for next term i.e. April 2022 – September 2022.
8. Student who renew their admission for April 2022 term will have to vacate hostel within 3 (three) days of completion of the Articleship (If ending before 30th September 2022, irrespective of fees paid for the month of September 2022) or on 30th September 2022, whichever is earlier.
9. Fees once paid shall not be refunded under any circumstances (even in case of a student not using the facility for single day)
10. Stay beyond three days post the dates mentioned in point 8 shall attracts penalty of Rs.590/- per day.
11. **Personality & Communication Skill Development Course (PCSDC):** If you have successfully completed PCSDC, attach photocopy of the certificate issued to you. If not, you will have to submit an undertaking that you shall complete the PCSDC Course on or before 31st March 2022 otherwise shall pay again Rs.2000/- (Non Refundable) for the same.
12. Student(s) who have cleared just one group of IPC exam and were given admission at RVG were expected to appear for December 2021 attempt. Kindly submit a valid reason with evidence if you have failed to appear for the attempt in December 2021. All students admitted with Single Group need to ensure that they need to appear for the MAY 2022 attempt for their pending group failing which they may not be allowed to continue with their stay at hostel.

4. True copy of Form No.109 with acknowledgement from ICAI (In case of Transfer of Articleship)
5. An undertaking from the local Guardian in the prescribed form along with the photocopy of the PAN Card.
6. Letter from Chartered Accountant Firm in the prescribed form (Any variation is not acceptable.)
7. Photocopy of the mark sheet, if not submitted earlier, of the last examination (Graduation exam)
8. Cancelled cheque of student's bank account. (In case of Change in bank account).
9. Pay Order/Demand Draft drawn in favour of "RVG Educational Foundation" along with its 2 photocopy.
